Subject: Examination Grievance for CTS Supplementary Examination-2024-reg

Sir/Madam,

The supplementary examination for Craftsmen training Scheme (CTS) was conducted by the DGT in Mar-April 2025 and result was declared on 1st May 2025.

2. The practical and Engineering Drawing examination were held in offline mode by state governments. The evaluations and uploading of the marks on the SIDH were carried by the examiners appointed by the states. The theory examinations in CBT mode were conducted by the DGT. The CBT examination response sheet will be tentatively made online in trainees' login by 17th May 2025.

3. Although it has been ensured that the evaluation and result processing remain qualitative and error-free, however, if trainees are unsatisfied with their result, they can raise an examination grievance on the SIDH Portal, for practical and/ or engineering drawing and/ or theory examinations.

4. The grievance can be raised within 15 days window period: 17th May -1st June 2025¹. The trainees are advised to go through the user manual, attached herewith, carefully before raising the examination grievance on the SIDH.

5. After closure of the grievance, trainee will be allowed one more appeal with the Controller of Examination, DGT through SIDH Portal.

6. The decision of the concerned authority viz. State/ DGT and CoE, DGT (in case of appeal) will be final and no further appeal or review for result will be entertained.



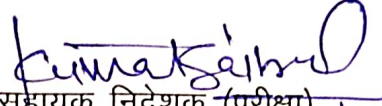
